2. THE NAME AND LOCATION OF THE REINVESTMENT ZONE IN THE IN WHICH THE PROPERTY SUBJECT TO THE AGREEMENT IS LOCATED APPROXIMATELY MIDWAY BETWEEN RIO HONDO AND LOS FRESNOS WITHIN THE RIO HONDO ISD, LOS FRESNOS ISD, TEXAS SOUTHMOST COLLEGE, PORT OF HARLINGEN, BROWNSVILLE NAVIGATION AND DRAINAGE DISTRICT #3 JURISDICTIONS.
3. A GENERAL DESCRIPTION OF THE NATURE OF THE IMPROVEMENTS OR REPAIRS INCLUDED IN THE AGREEMENT IS: THIS IS A WINDPOWER PROJECT WITH AN ESTIMATED GENERATION CAPACITY OF 198.45 MW FACILITY COMPRISING 63 WIND TURBINES EACH 3.15 MW.
4. THE ESTIMATED COST OF THE IMPROVEMENTS OR REPAIRS IS ESTIMATED TO BE A TOTAL INVESTMENT OF ABOUT \$215 MILLION.
