The meeting was called to order by Judge Hinojosa at 9:37 A.M. He then asked Reverend Bob Clark, Brownsville resident, for the invocation, and he then led the Court and audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on July 15, 2005, at 4:40 P.M.:

Judge Hinojosa read the Advisory Report released at 9:00 A.M. this morning, reporting that a westerly turn was anticipated for Hurricane Emily and that landfall was projected about 60 to 80 miles south of Brownsville around 10:00 P.M. He added that the slow moving Hurricane was expected to rapidly intensify and that strong surge flow and heavy rainfalls were expected. Judge Hinojosa reported that about 85,000 sand bags have been provided and an additional 30,000 would be prepared and provided. He stated that shelters have opened in Cameron and Hidalgo Counties and that a mandatory evacuation has not been issued.

Senator Eddie Lucio, Jr., commended Cameron County for the great teamwork being done in preparation for the possible hurricane impact, and stated that he would be in contact with State agencies to address needs. He cautioned people to stay indoors to prevent injuries due to flying debris. Senator Lucio congratulated the Court for being the caretakers of the people of Cameron County and offered his assistance.

Commissioner Tamayo stated that Representative Escobar offered his assistance.

Judge Hinojosa stated that he received calls offering support from Representative Escobar, a Representative from Senator Cornyn and Representative from Congressman Ortiz. He thanked State agencies and communities of Hidalgo County for their assistance and support.

Commissioner Benavides congratulated Judge Hinojosa for the fine job in handling preparations.

Judge Hinojosa thanked the county team and all departments for their participation in preparation. He stated that the county has also been working closely with communities and entities to ensure that the public is protected.

Commissioner Tamayo recognized Mr. Pete Sepulveda, Department of Transportation Director, for the great job done by the Public Works Department.

(1) PUBLIC COMMENTS

Mr. Doug Pearl, EDC, expressed concern with delay in payment to him for services rendered to the county at Browne Road Park.

The form is as follows:

Mr. Mark Yates, County Auditor, provided a list of purchases for emergency preparations totaling approximately \$45,000.00.

Commissioner Garza requested that department heads considered the form of compensation to employees working during these emergency times.

Mr. Yates stated that comp-time could be provided or time could be paid, and that reimbursement might be available if the county is declared "disaster area." He stated that the purchases made during this event must be inventoried to have it ready for the next event. Mr. Yates suggested that overtime rates be paid to employees if resources are available.

Mr. Remi Garza, County Administrative Assistant, noted the importance of document time worked for reimbursement purposes.

Upon motion by Commissioner Tamayo, seconded by Commissioner Wood and carried unanimously, this Item was **TABLED**.

PRESENTATIONS

(2) **PRESENTATION OF THE THIRD QUARTER REPORTS FOR THE INTERNATIONAL BRIDGE SYSTEM. (PS-DEPT. OF TRANSPORTATION)**

Mr. Pete Sepulveda, Department of Transportation Director, highlighted the Third Quarter International Bridge System Report to be at a positive variance of \$173,000.00.

Commissioner Garza moved that the Presentation of the Third Quarter Report for the International Bridge System be acknowledged.

The motion was seconded by Commissioner Tamayo and carried unanimously.

The Report is as follows:

Upon motion by Commissioner Benavides, seconded by Commissioner Garza and carried unanimously, the donation of \$2,500.00 from the Brownsville Downtown Lion's Club towards the community parks-handicap accessibility improvements was accepted.

Judge Hinojosa reported that the East Rio Hondo Water District postponed their meeting due to storm preparations.

Mr. Mark Yates, County Auditor, informed that his office owns accounts receivable software that can be implemented and ready to start-up billing within ten to twelve days.

Judge Hinojosa stated that there were issues other than software needed to be reviewed to allow implementation of the program, but he could not remember them at this time.

Mr. Yates stated that the collection issues needed to be reviewed, and that data was needed from the water districts for comparison to data from Red River Services Corporation to make sure that collection services are provided for payments rendered.

Mr. Remi Garza, County Administrative Assistant, stated that the equipment needed to sort and stuff envelopes was subject to the size of the bills; however, the District Clerk has equipment that may be used.

Commissioner Wood stated that said equipment would not be needed for a card system billing.

Mr. Yates stated that the initial billing might be on 8 ½" by 11" paper because preparations were ready and that this might have a bit more postage.

Judge Hinojosa suggested that the needed equipment be determined in the event that billing for the East Rio Hondo Water District area must be done by the county and since billing must be done for the water well customers regardless.

Upon motion by Commissioner Tamayo, seconded by Commissioner Wood and carried unanimously, this Item was **TABLED**.

(10) **IN THE MATTER REGARDING CONSIDERATION AND AUTHORIZATION TO REQUEST BIDS FOR THE RENOVATION OF THE LEVIS BUILDING. (PS-DEPT. OF TRANSPORTATION) (TABLED)**

Upon motion by Commissioner Tamayo, seconded by Commissioner Garza and carried unanimously, this Item was **TABLED**.

(11) **CONSIDERATION AND AUTHORIZATION TO CHANGE THE DIRECTION OF THE TRAVEL LANES AT THE VETERANS INTERNATIONAL BRIDGE AT LOS TOMATES. (PS-DEPT. OF TRANSPORTATION)**

Mr. Pete Sepulveda, Department of Transportation Director, presented proposed changes to Veterans International Bridge lanes due to traffic congestions. He stated that the proposed changes were done at the Pharr International Bridge and were working well. Mr. Sepulveda stated that a meeting between U.S. and Mexico took place and that a sixty day trial was proposed and to thereafter consider whether to make it permanent or not. He added that upon the changes being approved a two week period would be used to inform the public and that changes would be implemented in August.

Judge Hinojosa stated that traffic issues indicate the need to start working on the second span issue.

Mr. Sepulveda agreed, yet noted that the expansion would be a \$3 to \$4 million project.

Judge Hinojosa stated that both international bridges in Brownsville were at capacity and that not starting the timely process to obtain necessary permits to expand the bridges would be foolish.

Mr. Sepulveda stated that the \$3 or \$4 million project would fund two spans for the bridge to allow shifting of commercial traffic and noted that a presidential permit would be needed.

Judge Hinojosa stated that the expansion was needed because the chances of Brownsville Navigation District International Commercial Bridge being approved and built were slim due to the lack of needed Mexican infrastructure. He recommended that development of the necessary plan to do the second span begin because of the timely process, adding that the Veterans International Bridge already has the needed Mexican infrastructure.

Mr. Sepulveda stated that half the cost of the project is to be funded by the City of Brownsville.

Judge Hinojosa stated that the county has offered to work with the Brownsville Navigation District on the commercial truck bridge but they have expressed no interest, thus the county must now move forward on its agenda.

Mr. Sepulveda reported that commercial traffic increased at both Veterans International Bridge and at Los Indio International Bridge.

Commissioner Garza moved that the change of direction of the travel lanes at the Veterans International Bridge at Los Tomates be authorized.

The motion was seconded by Commissioner Wood and carried unanimously.
