Mr. David Garcia, Deputy County Administrator, reported that the Gateway International Bridge had an 11% decrease in bridge crossings with a 13% decrease in revenues, the Free Trade International Bridge had a 4% decrease in bridge crossings with a 7% decrease in revenues and the Veteran's International Bridge had a 17% decrease in bridge crossings with a 19% decrease in revenues.

**(B) PRESENTATION AND DISCUSSION OF PRELIMINARY REPORT ON FUNDING REQUESTS FOR THE 2008 DISASTER RECOVERY FUND. (FB-PD&M)**

Mr. Frank Bejarano, PD&M Director, informed the Court that 94 funding requests have been received.

Mr. Steve Brewer, Mayor of La Feria, stated that he and the remaining Advisory Committee members hope to narrow down the number of projects to 10-15 and will also compile a secondary list of projects in the event that more funding becomes available.

Commissioner Wood noted that the total amount of funding requests including engineering cost equates to \$50 million with only \$9.2 million available.

Mayor Brewer added that the Committee plans to ask each entity for a priority list as to the projects submitted.

Commissioner Tamayo asked for explanation as to the project request for improvements to Joines Rd.

Mr. Bejarano replied that the request is for \$125,000 and noted that project eligibility is being verified.

Ms. Rosie De Leija inquired as to how the Advisory Committee was selected.

Judge Pro-Tem Garza explained that the 6-member Advisory Committee was selected by Commissioners' Court with each Court member appointing one person and the County Judge appointing two persons with one of those appointees being from the Laguna Madre area.

Mr. Bejarano added that the Advisory Committee hopes to have a recommended list of projects by the next Commissioners' Court Meeting.
