INTERLOCAL COOPERATION AGREEMENT BETWEEN
THE COUNTY OF CAMERON AND THE CITY OF PRIMERA

THIS AGREEMENT is entered into and between the COUNTY OF CAMERON, TEXAS, hereinafter referred to as "COUNTY" and the CITY OF PRIMERA, hereinafter referred to as "CITY", on this 29th day of May, pursuant to the provisions of the Interlocal Cooperation Act and under the authority of Section 251.012 of the Texas Transportation Code.

WHEREAS, Cameron County is a county in the State of Texas;

WHEREAS, the City of Primera is a general municipality located in Cameron County, Texas;

WHEREAS, County and City, each pursuant to its statutory and constitutional authority, are responsible for maintenance and improvements of certain public roadways within their respective borders;

WHEREAS, City and County desire to provide and perform road improvements to Stuart Place Road located in the City;

WHEREAS, County has determined that the County will receive a benefit from the proposed improvements to Stuart Place Road, that such will serve a County purpose, and that Texas Transportation Code 251.012 permits the expenditure of County funds for such purpose;


WHEREAS, County and City are authorized to enter into this Agreement pursuant to the Interlocal Cooperation Act, Texas Government Code 791.001 et seq., Section 791.032 as well as under the terms of Texas Transportation Code 251.012;

WHEREAS, City, pursuant to Texas Transportation Code 251.012, requests and authorizes the County to perform the work and services described herein within its corporate city limits and to be partially funded by the County.


1. LOCATION OF PROJECT: Stuart Place Road, Primera, Texas.
2. WORK AND SERVICES TO BE PERFORMED: Reconstruction of Stuart Place Road.
3. City will be responsible for the materials for the project, with the County providing the labor and equipment. The improvements to Stuart Place Road shall be done in accordance to attached plans and specifications, Attachment "A" and cost estimate, Attachment "B".
4. The execution and performance of this Agreement by County and City have been duly authorized by all necessary laws, resolutions or corporate action, and this Agreement constitutes the valid and enforceable obligations of County and City in accordance with its terms.
5. This Agreement constitutes a one-time agreement between the parties and does not

constitute a continuing agreement or responsibility for maintenance of Stuart Place Road. Any future maintenance for Stuart Place Road will be the responsibility of the City.

6. Each party agrees to conform to its own applicable laws, regulations, policies, and procedures with respect to the performance of the work and services under this Agreement. The Agreement shall have no legal force or effect until such time as it is properly adopted and approved by the CAMERON COUNTY COMMISSIONERS COURT and the PRIMERA CITY COMMISSION. This Agreement shall terminate on completion of the project.
7. The parties agree that the County will be released of any and all duties imposed by this Agreement following completion of the work and service described in this Agreement.
8. All expenditures made under this Agreement will be made from the current revenues of the paying party and under the authority of Texas Transportation Code 251.012
