Consideration and Authorization to Award Low Bid in the amount of \$418,313 to Bell Water Well Service for electrical components and pumping equipment, for a new water well for the North Cameron Regional Water Supply Corporation (TDA Contract No. 713107).

The above reference water well project is funded through a \$350,000 disaster relief grant from the Texas Department of Agriculture (TDA) and local funding from the East Rio Hondo Water Supply Corporation and North Alamo Water Supply Corporation. The two corporations collectively constitute the North Cameron Regional Water Supply Corporation and are responsible for any project cost overruns.
